Any members of the household who are under 55 years of age must be either the partner, joint tenant or registered carer of the lead applicant. In most cases, we are only able to accept applications from household of one or two people. However we can consider a third person in exceptional circumstances. Please contact us if this applies to you.

Applicants should have no rent arrears or history of anti-social behaviour, and should not be going through possession proceedings or being evicted.
