Title: LEP Website

Executive Summary:

A funding allocation of up to £70,000 has been endorsed by the London Enterprise Panel (LEP) in order to design, produce and implement a standalone website for the London Enterprise Panel. Approval for the procurement of external web development services for these purposes is requested.

Decision:

That the Executive Director approves expenditure of up to £70,000 on services for the design, production and implementation of a new website for the London Enterprise Panel and any on-going costs for an initial period of three years.

PART I - NON-CONFIDENTIAL FACTS AND ADVICE

Decision required – supporting report

1. Introduction and background

A refresh of the LEP's web-pages within the GLA website

(www.london.gov.uk/londonenterprisepanel) was recently undertaken. Whilst this is a significant improvement on the previous content, the pages remain difficult to find within the GLA website and they fail to provide an adequate stakeholder facing online presence for the LEP as a partnership between the Mayor, London Councils and London's business community. We are therefore proposing to migrate (and build upon) the current content with a separate LEP website. This site would not seek to duplicate existing information and services provided by www.london.gov.uk and would sign-post to other sites as relevant. In particular, business support information would not be included within this site, as this is being developed separately as part of the new london.gov.uk website.

At its meeting on 7 January, a funding allocation of up to £70,000 was endorsed by the LEP in order to design, produce and implement a standalone website for an initial period of three years. This will be delivered through the procurement of an external web developer. The specification for the site is being developed by the LEP Secretariat with support from the Technology Group and the Marketing Team in order utilise in-house expertise and resources.

Officers will aim to remove, or at least minimise, any ongoing costs and will not commit to expenditure over and above the 3-year period and £70,000 funding cap. This will be achieved in part by the use of a domain name provided free of charge by Dot London Domains Ltd and hosting on GLA servers. On-going costs will therefore be limited to support which would be provided on a call-off basis. Other support from within the GLA will also be sought as applicable.

Scope of activity

The scope of the activity will include:

- Site-wide design and production;
- Integration with the GLA's existing committee decisions management system (Modern.gov),
- Provision of site for hosting on GLA servers and integration with a domain name (<u>www.lep.london</u>) provided by Dot London Domains Ltd;
- Site testing;
- Site launch;
- Any maintenance and support costs for a period of three years

All to be delivered to the satisfaction of the GLA.

Procurement Route

A Request for Quotes (RfQ) and a full Requirements Catalogue are being developed. In line with the GLA's Contracts & Funding Code, a minimum of three written quotes will be sought via TfL Procurement. Use of an existing TfL or GLA Framework agreement has been considered and the Technology Group have advised that there are no existing Frameworks that would be suitable for this relatively small piece of work.

2. Other considerations

The work of the London Enterprise Panel plays a key role in supporting the Mayor to deliver one of the three principal purposes of the Authority, namely "promoting economic development and wealth creation in Greater London".

3. Financial comments

- 3.1 The cost of the standalone LEP website, inclusive of on-going costs from 2014/15 to 2016/17, is up to a maximum of £70,000 and will be funded from the LEP's 'Strategic Plans and EU Funds Investment Strategies budget. The allocation of the funding was approved by the LEP board at its meeting of the 7^{th} January 2014.
- 3.2 Any changes to this proposal, including budgetary implications will be subject to further approval via the Authority's decision-making process. All appropriate budget adjustments will be made.

4. Legal comments

- 4.1 The foregoing sections of this report indicate that the decisions requested of the Director fall within the GLA's statutory powers to do such things considered to further or which are facilitative of, or conducive or incidental to the discharge of its principal functions, in this instance the promotion of economic development and wealth creation in Greater London). In formulating the proposals in respect of which a decision is sought officers have complied with the GLA's related statutory duties to:
 - pay due regard to the principle that there should be equality of opportunity for all people;
 - consider how the proposals will promote the improvement of health of persons, health inequalities between persons and to contribute towards the achievement of sustainable development in the United Kingdom; and
 - consult with appropriate bodies.
- 4.2 All supplies and services required for the proposed development of LEP website must be procured by Transport for London Procurement (who will determine the detail of the procurement strategy to be adopted) in accordance with the GLA's Contracts and Funding Code. Officers must liaise with Transport for London Procurement in this regard and in order to ensure that an appropriate contract is put in place between and executed by the GLA and the successful bidder before the commencement of the supplies and services in question.
