#### Decision required – supporting report

#### 1. Introduction and background

1.1 DMPC approved on 3 February 2012 (ref DMPC 2012 03) the delegation to DLS for the management of RDA claims arising from the August 2011 disturbances. The vast majority of the straightforward claims have been resolved, this paper addresses one of the more complex claims, and proposes a final payment.

#### EXECUTIVE SUMMARY
