- 5.2 Gareth Bacon AM attended the meeting to answer the Committee's questions in relation to his proposed appointment to the office of Chairman of the London Fire and Emergency Planning Authority (LFEPA).

- 5.6 The Committee noted and was reassured by Gareth Bacon's affirmation that he would make his work with the Fire Authority his priority, and that he would review his other commitments should he find it difficult to meet the demanding role of Chairman of LFEPA.
