### 1 Apologies for Absence and Chair's Announcements (Item 1)

- 1.1 Apologies for absence were received on behalf of Tom Copley AM, Florence Eshalomi MP AM and Caroline Russell AM.
- 1.2 The Deputy Chairman in the Chair welcomed home education students and their families visiting with 'Educational Events' to the public gallery.
- 1.3 The Deputy Chairman in the Chair, then provided an update on some recent Assembly activity, including: the Budget and Performance Committee's questioning of the Mayor, TfL and Old Oak and Park Royal Development Corporation on the 2020-21 proposed Budgets; the publication of the Budget and Performance Committee's response to the Mayor's Draft Consultation Budget 2020/21 highlighting the areas on which the Committee would like the Mayor to provide further clarity; and the Health Committee's publication of a report on the scale of adverse childhood experiences in London, calling on the Mayor and the London Health Board to create an action plan.
- 1.4 Finally, the Deputy Chairman offered congratulations on behalf of the Assembly to all Londoners and GLA family colleagues who had received awards in Her Majesty the Queen's New Year's Honours List. In particular, congratulations were extended to former Assembly Members, Dame Diana Ruth Johnson MP and Sir Bob Neill MP, as well as the emergency services workers who had received honours as a result of their commitment to keeping Londoners safe. Finally, congratulations were extended to Andy Roe on his appointment as the new London Fire Commissioner and to Andrew Boff AM for his election as Deputy Leader of the GLA Conservatives Group.
