We are writing on behalf of Brentford Football Club, which currently plays its football in the English Football League Championship, with keen ambitions to play in The Premier League in the near future. The Club currently has its training ground located on Metropolitan Open Land in Osterley, and is in the process of exploring its options for improving and enhancing its facilities on the same site in the future.

In this regard, we are aware that representations have been made on behalf of Fulham Football Club with respect to Draft London Plan Policy S5 - Sports and Recreation Facilities, specifically with regard to elite performance sport, the very special circumstances surrounding it and Metropolitan Open Land.

Having reviewed the Draft London Plan and Policy S5 ourselves, we are now writing on behalf of Brentford Football Club to state our strong support for the representations made on behalf of Fulham Football Club, and would like to reiterate their comments again as follows:

"London is home to numerous professional sporting teams and athletes across a wide variety of sports. These sports have both venues and training facilities throughout the Capital and contribute significantly to London's economy and reputation as a centre of sporting excellence. They also help to encourage take up and participation of sport and perform an important role in London's sporting eco-system.

The draft London Plan fails to acknowledge elite performance sport or provide any policy support for the protection of existing facilities or the need to improve and enhance facilities so as to ensure that professional sporting clubs, and the facilities that support them, can remain at the forefront of sporting excellence both nationally and internationally. As such, Policy 'S5 Sports and Recreational Facilities' fails to plan positively or strategically for elite sport and should be amended to include a new sub-category to the policy, which states:

"London is a centre of excellence for elite performance sports. The needs and requirements of elite performance sport differ from those of amateur and community sport and such differences should be acknowledged when considering development proposals. The London Plan supports the provision and enhancement of elite performance sports facilities to meet the needs of both Clubs and athletes to ensure that London maintains its position as a preeminent location for elite performance sport both nationally and internationally."

The adopted London Plan contains Policy 4.6 'Support for and enhancement of arts, culture, sports and entertainment' contained support for professional sporting enterprises.
