Support the police objective that all parts of London need to embrace and manage change and Outer London, where the suburban pattern of development has significant potential, has the opportunity for appropriate intensification over time, particularly for housing; the Opportunity Areas (OAs) to be clustered into strategic Growth Corridors; the Central Activity Zones (CAZs) and Town Centres, and for many the surrounding areas have potential to accommodate significant quantities of new housing as part of mixed-use development and integrating community and leisure activities and the Strategic and Local Regeneration Areas to be the focus for sustainable and inclusive regeneration.

There is general support for policies that encourage good design and good planning and development should be fit for purpose and respond to the changing needs of London and make the best use the city's finite supply of land. The efficient use of land requires optimisation of density.

Page: Policy H1 Increasing housing supply

Section: N/A

Welcomes the approach set out in the Plan to deliver housing and to meet the needs of the Londoners within the plan area, however the major concern is that Strategic Housing Land Availability Assessment is only able identify land for the first ten years of the Plan, whilst the Plan covers period of 22 years. How will Mayor deliver similar level of housing demand for remaining 12 years of the Plan.

The Plan should also set out the consequence if housing delivery rates fail to increase the supply of housing and how the situation will be managed within London or would the Mayor be seeking support from further afield.

There is a need for greater clarity on how London would manage its own housing pressures, policies and delivery rates, local planning authorities outside London should not be pressurised or asked by Inspectors, to explain how they propose to address housing delivery shortfalls within London.

Housing delivery shortfalls within the capital should be a matter for London to deal with, perhaps by means of a review of the Plan or alterations to it. There may also be merit in the Plan to identify a trigger point for such a review or alterations – a specific number of years of failure, for example.

Page: Policy H2 Small sites

The target for small sites is very ambitious as in previous London Plan reviews they have been unable to demonstrate the available and capacity of small sites, however they provide an opportunity for early delivery. The County Council welcomes the approach, but the evidence needs to demonstrate that there are available sites to deliver this level of homes.

The 25-year Environment Plan includes proposals to seek to embed a "net environmental gain" principle for housing and infrastructure development. It says that current policy is that the planning system should provide biodiversity net gains where possible, but adds: "We will explore strengthening this requirement for planning authorities to ensure environmental net gains across their areas, and will consult on making this mandatory – including any exemptions that may be necessary".

The London Plan should be more strongly aligned with this aspiration

2) Using a "natural capital" approach to protecting and enhancing the environment

The Defra 25 year Plan describes how in the past "our failure to understand the full value of the benefits offered by the environment and cultural heritage has seen us make poor choices." The Government's aim is to address this by using a natural capital approach to protecting and enhancing the environment, by recognising tangible and non-tangible economic benefits. The Plan states:

"When we give the environment its due regard as a natural asset – indeed a key contributor – to the overall economy, we will be more likely to give it the value it deserves to protect and enhance it"

As part of the Plan the Government pledges to:

"...set gold standards in protecting and growing natural capital – leading the world in using this approach as a tool in decision-making. We will take into account the often hidden additional benefits in every aspect of the environment for national wellbeing, health and economic prosperity,"

The County Council is conscious that the London Mayor has just published a natural capital account for London
