## FSM Registrations – what's going on?

#### Some of the national context includes:

- •DfE Transitional Protections mean that those already registered for FSM will continue to receive FSM and Pupil Premium until 2025 (and then until end of their stage of schooling)
- •Roll-out of London Mayor KS2 universal primary will not affect those already registered
- You should be able to continue existing processes you have in place for KS1
- •There is a wider issue of under-registration but not known!
- •Pilots and programmes under-way to explore better processes
  - •Gaining explicit consent at different benefits touchpoints
  - Use of opt-out 'right to object'



## Advice for Boroughs

#### Whilst recognising that there is no one size fits all....

- •Do you have a best practice process flow agreed with your schools?
- •Does FSM registration always flow through with the pupil Common Transfer File?
- •How consistent is your passporting of information from your benefits teams to schools?
- •Have you considered other benefits contact points or opt-out mechanisms?

# GLA Good Practice Islington approach

#### Context

- May 2009: Members agreed Free School Meals would be provided to all primary aged children
- 6 x pilot schools were identified to commence September 2009 chosen by: demographics; FSM % and meal take-up
- All remaining schools to 'go live' 8 March 2010
- Islington were using paper based forms for FSM assessment



## Challenges

- Resources
- Increased meal take-up; capacity to deliver; kitchen equipment
- Potential loss of income to schools, linked to FSM eligibility:
  - Funding Formula
  - Grants
  - Latterly Pupil Premium



## Islington approach: Overview

- Every primary aged child to be assessed for FSM eligibility prior to roll-out
  - 13,000 on roll
  - Parents to register (and supply income banding)
- Introduce a differing use of language:
  - Application vs Registration = Secondary vs Primary
  - FSM = FSM eligible (National Criteria)
  - Permitted = permitted to have a meal through Islington's UFSM policy as child has been assessed for FSMs under the National Criteria but deemed ineligible
  - Not eligible = child has not been assessed for FSMs and therefore not permitted to have a meal



## Islington approach: How (Then)

- Regular communications / advertising with schools & parents
  - Letters / Flyers
  - Registration Forms (incl benefits for completing) asks for the same information as for FSM eligibility assessment
- Focused engagement with School Business Managers
  - Briefings
  - Small group training sessions led by LA but with support from members of 6 schools
  - How to record a child's meal uptake in SIMS
- Use of admissions and census data to cross check returned forms to those listed in the school
  - Schools returned in batches not individual forms
- Expanded FSM team assessed forms, updated central system and sent regular reports to schools
  - Each school had link FSM officer
- Annual process continued for 2-3 years
- Labour intensive Resource heavy



## Impact on initial roll-out of UFSM

- On average:
  - Return rate of forms: 90% 95%
  - Take-up of meals: 28% increase overall (58% to 86%)
  - Increase in FSM eligibility: 10% increase (ranged between 0% 16%)



## Islington approach / How (Now)

- Islington use an online system to assess FSM eligibility
  - Linking directly to FSM module and reports
- Registration process applicable to September intakes, plus any in-year starters
- Once a parent has registered: details remain in the system and audited every summer
- FSM eligibility: transitional Universal credits arrangements means FSM eligible pupils will continue to be eligible until 31 March 2025, and then to the end of school phase they are in



### Statistics: Now

- On average:
  - Return rate of forms: 85% 90%
  - Take-up of meals: pre-pandemic 88%, now 84%
  - FSM eligibility: demographically reduced over the period, increasing again since and during pandemic



## Key Messages

- Work closely with and fully engage with School Business Managers
- Schools are already working to a process as part of KS1 offer from DfE
- Resources are in place for whichever systems used
