

**DMPC Decision – PCD 636**

**Title: National Police Chiefs Council Additional Home Office Funding – Brexit Preparations 2019/20**

**Executive Summary:**

The Home Office has agreed to provide additional funding of up to £1.053 million to the National Police Chiefs Council for contingency planning and preparations for Brexit in 2019/20. As MOPAC host the National Police Chiefs Council, this paper requests approval to accept this funding. There is no financial exposure to MOPAC.

**Recommendation:**

The Deputy Mayor for Policing and Crime is recommended to agree that MOPAC receive, on behalf of the National Police Chiefs Council, the additional 2019/20 funding provided by the Home Office of £1.053m to enhance the International Crime Cooperation Centre capability by up to 12 Full Time Equivalent to support Back Record Conversion, Foreign National Offenders, and Communications and Training.

## **PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC**

### **1. Introduction and background**

- 1.1. The MPS host the National Police Chief's Council (NPCC), providing business support services, under a nationally agreed collaboration agreement.
- 1.2. The Home Office previously approved funding of up to £5.6m for 2019/20 for the operational continuity of the International Crime Cooperation Centre (ICCC). This is formed of a central coordination team based in London and a network of regional single points of contacts (SPOCs) who provide advice and help forces to use alternative mechanisms to provide policing with mitigations of the potential consequences of Brexit.
- 1.3. The Home Office has indicated that it is willing to provide additional funding for 2019/20 to enhance the ICCC capability by up to 12 FTEs to support Back Record Conversion (BRC), Foreign National Offenders (FNO) and Communications and Training.

### **2. Issues for consideration**

- 2.1. The NPCC has estimated the additional operating costs for 2019/20 are within the original Home Office grant approval of £5.6m (PCD529) and this additional funding of £1.053m. The NPCC is seeking MOPAC approval to accept the HO grant funding.

### **3. Financial Comments**

- 3.1. The NPCC have assured that the estimated costs will be fully funded from HO grant. Any costs not met by the HO grant funding will be funded from the NPCC budget and reserves. There is no financial exposure for MOPAC

### **4. Legal Comments**

- 4.1. Under the Police Reform and Social Responsibility Act 2011 police and crime commissioners "must (a) secure the maintenance of the police force for that area, and (b) secure that the police force is efficient and effective". Under paragraph 4.8 of the MOPAC Scheme of Consent and Delegation the DMPC must approve "Bids for grant funding made and all offers made of grant funding; and/or where appropriate a strategy for grant giving".



The NPCC Brexit Contingency Planning Team led by DAC Richard Martin (NPCC – International Criminality Portfolio) has stood up a new unit called the International Crime Coordination Centre (ICCC) in readiness for EU Exit day.

The ICCC has been operationally ready since March 2019 and sits under the leadership of NPCC International Criminality Lead DAC Martin.

Funding has been agreed with the Home Office for this financial year and discussions are ongoing regarding beyond 2019/20. The ICCC is currently hosted by the Met Police but it is a national resource under NPCC governance.

A decision is required from MOPAC on behalf of NPCC, to receive the additional 2019 /20 funding provided by the Home Office to improve the ICCC capability and operational continuity of the ICCC.

**Recommendations**

The Deputy Mayor for Policing and Crime is asked to consider the following:

1. MOPAC agree to receive, on behalf of the NPCC, the 2019/20 additional funding provided by the Home Office to increase capability and guarantee continuity of the ICCC. The ICCC has been implemented as the policing contingency response to mitigate the risks associated with a potential EU Exit.

**Non-confidential facts and advice to the Deputy Mayor for Policing and Crime****Introduction and background**

2. The NPCC Brexit Contingency Planning Team led by DAC Richard Martin (NPCC – International Criminality Portfolio) received the required funding for 2018/19 to set up a new unit called the International Crime Coordination Centre (ICCC). It was agreed that the unit would be hosted by the Met Police but would be a national resource under NPCC governance.

3. On 4 March 2019 the NPCC launched the newly formed and fully operational International Crime Cooperation Centre (ICCC). This arrangement provided confidence that UK law enforcement (particularly the 43 police forces in England and Wales) were prepared to revert to the non-EU contingencies from Day One (29 March 2019) should the UK exit the EU.
4. The ICCC is staffed by highly experienced officers and staff from police forces, the National Crime Agency and the National Criminal Records Office with a central coordination team based in London and a network of regional single points of contacts (SPOCs) who provide advice and help forces to use alternative mechanisms.
5. Following a Home Office request, in September 2018 the NPCC submitted a proposal to the Home Office in relation to a funding request for 2019/2020 for two scenarios: a) No Deal Scenario and b) Deal Scenario. In January 2019 the HO confirmed that funding for up to £5.6M had been approved for 2019/20 to guarantee the operational continuity of the ICCC.
6. In June 2019, the Home Office commissioned the NPCC to review the No Deal funding bid original submitted in September 2018 taking into consideration the new 31<sup>st</sup> October 2019 deadline and the progress already made by the ICCC. In August 2019, the Home Office confirmed that a further £1.053M had been approved to expand the ICCC capability.
7. The additional £1.053M was approved to enhance the ICCC capability by up to 12 FTEs to support Back Record Conversion (BRC), Foreign National Offenders (FNO) and Communications and Training.
8. Funding applies only to 2019/2020. Although further funding is still uncertain, the NPCC – ICCC submitted a 4 years funding bid for the ICCC beyond 2020 and regardless of the outcome of Brexit. The Home office is currently reviewing the allocations for this future funding.

**Issues for consideration**

9. Although the UK negotiated an extension until October 2019, there is still uncertainty regarding the future of the UK EU's membership and there remains a risk of a No Deal Brexit. In this case the UK will lose access to European measures, tools and mechanisms.
10. These EU instruments are used on a daily basis in operational policing and loss of them will have a significant impact on both UK and EU law enforcement. Frontline officers will be less connected to alerts from EU partners about suspects they encounter and it will be harder to monitor the movements of sex offenders or terrorist suspects if we lose Schengen Information Systems II (SISII).
11. Brexit only increases the challenges that the UK faces when dealing with international crime, not only EU related but also from other countries. The structure

of the ICCC can be flexed to respond to those challenges and to help to equip the UK policing to improve the way it deals with international crime.

### **Contribution to the MOPAC Police & Crime Plan 2017-2021<sup>1</sup>**

12. The ICCC will contribute to the MOPAC Police & Crime Plan as it will mitigate the impact of the UK losing access to EU tools. The ICCC's ultimate objective is to keep communities safe. Access to mechanisms to share intelligence and evidence with international counterparts is a vital component in this.
13. The ICCC will continue to provide support to front line officers to respond to international threats and build up International Criminality capability within forces.

### **Financial, Commercial and Procurement Comments**

14. The policing costs associated with the ICCC will be funded by the Home Office with no permanent revenue cost to policing. This will be via a special grant to MOPAC who will then administer all financial arrangements on behalf of the NPCC.
15. Previous decision PCD 529 approves the receipt of the original £5.6M funding for 2019/2020. This paper only request authorization to receive the additional £1.053M.
16. The terms of the grant agreement has been agreed with the Home Office. The grant agreement will cover all the funding granted for 2019-2020, this is the initial £5.6M plus the additional £1.053M, therefore the grant agreement will be produced to cover any necessary and eligible expenditure incurred by the NPCC related to Law and Enforcement preparations for EU exit up to a maximum of £6.653M for 2019/20.
17. The Home Office have only granted funding for the current financial year and is currently reviewing the NPCC's bid for ICCC's funding beyond 2020.
18. NPCC has revised its budget forecast for this financial year and is confident that the funding granted by the HO are sufficient to cover the operating costs of the ICCC as it is. Despite the above if there are over-costs which are not funded by the HO grant funding NPCC assure that these costs will be met from within existing NPCC budget and/or reserves.

### **Legal Comments**

19. Under the Police Reform and Social Responsibility Act 2011 police and crime commissioners "must (a) secure the maintenance of the police force for that area, and (b) secure that the police force is efficient and effective".
