The Coordinator took a proactive problem-solving approach, meeting with the client to discuss political sensitivities and agree the key priorities and expectations. The Coordinator used GLA data resources – IMA and NUAR – and established stakeholder contacts to gather information on utility plans for the area. Normally, this information would have been gathered by several consultants later in the process, but taking this approach, the Coordinator collated the work in one document early on, mitigating changes later in the design process.

### Summary

The Coordinator created a report to inform conversations with developers that fed into the Purley Way Masterplan and the Croydon Local Plan.

While there was no statutory requirement for such work, establishing existing utilities information at this strategic point saved time and money, by highlighting key considerations and constraints that had not been previously known.
