Further Alterations to the London Plan 2015

RoSE consultation responses April 2014

- London isn't meeting its housing needs
- London hasn't done a Green Belt review
- FALP doesn't plan for adequate infrastructure across London / Wider SE
- need a better understanding of common issues
- London Plan should be bound by the Duty to Cooperate
- uncertainty in London planning makes planning outside London uncertain
- more effective engagement in the next London Plan review



London: indicative growth to 2041

Pop: 8.6 mll (2015)

Pop increase: 76k pa (2036), and cld be similar for longer term


Hhlds: 3.4 mll (2014)

Hhlds increase: 40k pa (2036) but cld be +43k pa for longer term

Housing need: 49k pa (2036), but cld be low/mid 50s for longer term

Emp: 5.6 mll (2015)

Emp increase: 32k pa (2036) but cld be low 40s for longer term




Towards Full London Plan Review

- Opportunity Areas review




Changing roles for Opportunity Areas?




Modelling 'what if' forms for the future

CONTEXT

The Duty to Cooperate requires continuous collaboration and engagement by authorities on strategic cross-boundary matters.

The NPPF and NPG sets out what are the strategic matters.

Members in the Wider South East have requested through the first Summit and the Roundtables a better understanding of the evidence base to support collaborative working.



PROGRESS TO DATE

Initial scoping work underway - preparing a "stocktake" which audits existing work at various levels, identifies gaps and future potential work streams;

Given emerging member priorities for collaborative working, focus so far been on scoping existing and emerging evidence (see Annex Report 2) on key issues

- **Demographics and Housing**
- Economy
- Transport/Infrastructure
- Ongoing Minerals and Waste

Exploring potential areas for joint collaboration of the evidence base.

e.g. various demographic or economic models





KEY ISSUES

- What might be needed to support members' priorities for collaboration (eg influencing London Plan Review; tackling barriers to housing delivery; infrastructure investment)?
- ➤ Possible core areas include understanding of the demographic and economic data; transport/commuting data?
- Resources and staff to take forward the evidence base re the Summit?



NEXT STEPS

- Agree the priorities and recommendations at the Summit (Recommendations 2 & 3)
- To help the Political Steering Group consider the best way forward, Officers to progress scoping possible key technical evidence/understanding that may be needed and resource implications/costs
- Further explore areas of joint collaboration


Addressing Barriers to Housing Delivery What's the problem?

- Challenge for us <u>all</u> South East, East & London

 turning locally-approved housing plans into
 reality.
- Industry often slow to build out; infrastructure challenges; capacity/skills issues.
- Barriers to be tackled. But planning system is not the constraint on delivery...



Housing delivery: Targets & permissions vs delivery



 London - Planning <u>approvals well above</u> London Plan target, but <u>completions well below</u> target.

 SE local councils - planning for around 33-35k homes p.a., but completions around 22k p.a.

Addressing Barriers to Housing Delivery How can we tackle the problem? Welcome your views/suggestions to consider in taking joint work forward e.g.

- Local discretionary powers eg. 'contract' planning permissions / shorter time limits / council tax?
- Infrastructure funding/delivery?
- Construction capacity & skills eg. local control of skills budgets?
- Public sector building / land?
- Land assembly / CPO powers?
- Larger site delivery; and smaller developers/sites?
