## Rapporteur's Foreword



Having played football and cricket on many of London's playing fields during my school, college and now my adult life, I know too well the controversies surrounding the loss of playing fields.

Two key things struck me during our inquiry. Not enough use is made of the planning framework to protect our playing fields in London, and the sporting communities who regularly using them are not recognised as **custodians** of green spaces of London.

I hope this report can go some way to preserving London's playing fields, increasing access to, and use of them. Our report should be seen as a reference guide for all those who are working to maintain and develop playing fields. In it we:

- Attempt to learn the lessons of recent loss of playing fields.
- Map the nature of the growing relationship between artificial turf pitches (ATPs)
  and grass playing fields, so as to find innovative approaches to fund their long term
  future; and
- Set up baseline data and maps on playing fields availability across London beyond
  just school ones, covering others in the rest of the public sector and private ones
  which will help draw a line under the issue.

Like many off-side decisions in football, it's often not worth looking back on the ref's decision but lets look ahead instead. And the best way to do this will be to have an annual check on where we are with this head count of playing fields in 2006.

Hopefully this way we can maintain the 1500 playing fields we have identified for the future use of Londoners in the lead up to and beyond the Olympic & Paralympics in 2012.

## **Executive Summary**

Green spaces are important to our well-being and quality of life. Sadly, over the last two decades London has suffered significant loss of green spaces.

This report focuses on, and highlights the importance of preserving playing fields - London's green spaces used for sport. In doing so it addresses three themes:

- The strong links between the environment and health, and the importance of opening up access to London's playing fields to achieve health benefits.
- The need to engage all sections of the community, including the sporting community in the debate on preserving London's playing fields.
- The need to ensure that an appropriate planning framework is in place and that the current review of the Mayor's Spatial Development Strategy, the London Plan takes account of any changes needed.

Although the trend in loss of playing fields in London seems to be reversing, there is no room for complacency<sup>1</sup>.

We argue that the best defence against the loss of a playing field is intensive use by the local community. If sites are to be protected and created for future generations to enjoy, providers of them must ensure that they are accessible, safe and attractive to local people. Effective use of the planning framework, along with joined-up thinking, partnership working and the exploration of innovative models for financing is essential.

#### We therefore recommend:

- A single definition for a playing field to be used by Sport England and the Department for Education and Skills.
- A central database of playing field availability across London.
- Representation from the local sporting community on the London Parks and Green Spaces Forum.
- Increased access to privately owned playing fields and the development of a forum to facilitate that
- Inclusion of specific policies in the revised London Plan to protect playing fields against development
- More pressure on local planning authorities to complete Open Space Strategies.
- A sub-regional approach to developing Open Space Strategies.

### **Chapter 1 Introduction**

- 1.1 Green spaces are important to our well-being and quality of life. There are a range of benefits they can provide. Green spaces are pleasing to look at, can make our living and working environments more enjoyable, provide opportunities to socialise, develop team and community spirits and help improve our health through sporting activities.
- 1.2 Sadly, over the last two decades London has suffered a decline in its green spaces. A report published by the London Planning Advisory Committee (LPAC) in November 1999 confirmed that a large proportion of London's open spaces have been lost since 1991. On the basis of these losses, the LPAC went on to estimate that between 1989 and 1999 over 1000 hectares of open space will have been lost<sup>2</sup>.
- 1.3 The LPAC figures give an indication of loss of open space in London over the last 15 or so years. However we found it difficult to track down more recent data that would allow us to precisely quantify loss of playing fields in London, and discuss why in the following chapter. Suffice it to say that a range of data sources point to a significant loss of playing fields in London since the 1980s.
- 1.4 We acknowledge that the trend in loss of playing fields in London seems to be reversing. Government statistics published in July 2005 showed an increase in the number of playing fields and new sporting developments, for the first time since statistics have been published<sup>3</sup>. In London, 13 more new facilities were recorded in 2003/04 with an increased investment of £31,995,072<sup>4</sup>. But there is no room for complacency.

#### Focus for the inquiry

- Our inquiry, and consequently this report focuses on, and highlights the importance of preserving London's green spaces used for sport playing fields. Why? Three reasons. Firstly, we recognise the strong links between the environment and health, and the importance of opening up access to London's playing fields. Recently there has been a noticeable drive at national level towards improving the nation's health. In Game Plan 2002<sup>5</sup>, the Government set a target to increase participation in sport and physical activity by 1% year on year. More recently the Government published the white paper 'Choosing Heath: Making healthy choices easier', which aims to increase physical activity levels across the whole population as a preventative health measure<sup>6</sup>.
- 1.6 Secondly, it is important to engage all sections of London's community in preserving London's green spaces. The contribution that London's sporting

community has to make has not been fully recognised. Working with other key stakeholders, such as the boroughs, planners, developers and playing field owners, a more strategic approach to preserving existing playing fields and developing new ones can be achieved. Input from the sporting community is key and will become increasingly relevant in the lead up to the Olympics.

- 1.7 Thirdly, the land use planning system is a crucial mechanism for protecting playing fields. The Mayor's Spatial Development Strategy,<sup>7</sup> the London Plan, proposes significant increase in demand for land use in London; these include increases in population eight million by 2016; housing 306,500 more homes between 2007 to 2017; and waste management facilities needing 244 hectares of land between 2005 to 2020.
- 1.8 The Mayor may be confident that the increased targets for providing new homes will not compromise other policies in the London Plan such as the continued protection of green space. However, we need to ensure that the London Plan delivers on the Mayor's convictions with policies that adequately protect London's existing playing fields and offers opportunities for the development of new ones. The forthcoming review of the London Plan will allow for timely reflection of the Mayor's current policies on protecting open space, particularly playing fields.
- 1.9 The remit for our inquiry was to investigate the loss of green spaces used for sport. We discovered that much work had already been done on the loss of school playing fields. We acknowledge the importance of the need to preserve school playing fields, and touch on this in the following chapter. However, we recognise that there is a wider debate on playing field loss to be had. We need to examine what is happening to privately owned playing fields, and those owned by other parts of the public sector, and how we go about opening up access to them, particularly in areas of deprivation.
- 1.10 We chose to concentrate on identifying what playing fields are available in London. We also examined what more can be done to increase access, and how in the current climate of competing priorities for land in London, we can look to maintain our existing playing fields and even develop new ones.
- 1.11 We met with and received written submissions from a range of stakeholders, many of whom were happy to share their individual experiences. We also completed desk based research. We draw on our research and discussions with stakeholders throughout the report.
- 1.12 We hope our findings and research, setting out the current availability of playing fields in London will provide a baseline for any future research.

## Chapter 2 Availability of London's playing fields

#### Defining a playing field

- A playing field is defined as "the whole of a site which encompasses at least one playing pitch". The definition is set out in The Town and Country Planning General Development Procedure Order 1995 (as amended), along with a more detailed explanation of the size of a pitch, the type of sports that can be played on it, and the type of surface the pitch may have.
- 2.2 The Order defines a playing pitch as an area measuring 0.4 hectares or more and, which is used for certain specified team games including football, rugby, cricket, hockey, and rounders<sup>9</sup>, but not golf courses, tennis courts and bowling greens. A playing pitch may have a grass or artificial surface.

#### School playing fields

- 2.3 School playing fields and other educational land are not the main focus of this inquiry. However some of the main issues that beset school playing fields are applicable to the wider debate on loss of playing fields. One worth emphasising here is the problem working to different definitions causes.
- 2.4 The lack of consistency in defining a playing field may be an unwitting contributor to the loss of London's playing fields. The above definition (paragraph 2.1) is incorporated in Sport England's<sup>10</sup> guidelines who must be consulted on any developments affecting playing fields measuring 0.4 hectares or more. The definition differs from the one used by the Department for Education and Skills (DfES) in their guidance relating to the sale of school playing fields. For the DfES definition an area measuring 0.2 hectares (a mini football pitch) or more is used. In such cases Sport England may be consulted, but on a non-statutory basis.
- 2.5 An opportunity for two key government bodies to work together more closely to protect playing fields is being lost. Ensuring that the smallest playing field on which Sport England should be consulted when an application for development is made is 0.2 as opposed to 0.4 hectares will bring both definitions in line. It will also create greater opportunity for closer working at national level. In July 2002, the former ODPM announced that new legislation would be introduced to protect smaller playing fields by reducing the size threshold from 0.4 hectares to 0.2 hectares<sup>11</sup>.

#### Recommendation 1

We recommend that the Government revise Town and Country Planning General Development Procedure Order 1995 (as amended), to require Sport England to be consulted on all applications for developments on playing fields measuring 0.2 hectares or more.

#### Quantifying playing field losses in London

- Quantifying London's loss of playing fields is a complex task. It is not always easy to keep track of the wide range of possible owners. Playing fields may be privately owned. These owners may include companies, banks, sports clubs, developers, or individual land owners not necessarily associated with any commercial enterprise. Playing fields may also be owned by a range of public sector organisations including local authorities and schools and colleges managed by them, or other bodies such as the Civil Service, National Health Service or Port of London Authority. Other playing fields may be owned by voluntary or charitable sector bodies, including schools and colleges sponsored by them.
- 2.7 Restrictions in statutory requirements can also cause problems. The Town and Country Planning (Playing Fields) (England) Direction 1998 applies to playing fields owned by local authorities and education institutions, currently in use or which have been in the past five years. Under the direction, local planning authorities (in London, the boroughs), must notify the Government Office in cases where they have decided to go ahead and grant planning permission for a proposed development, which has been objected to by Sport England. This process of referral allows for 'call-in' of the decision, i.e intervention by the Secretary of State. No such referral exists for other privately owned playing fields. In addition, there is no statutory requirement to consult with Sport England on playing fields that have remained disused or derelict for more than five years, or which cover less than the minimum area protected by legislation 0.4 hectares. Such playing fields are at risk of being sold on for development and the loss remain unrecognised.
- 2.8 Equally challenging is the range of data available. Data may be collated using different definitions for 'a playing field', as discussed in paragraphs 2.4 and 2.5 above. Different methods may be applied to calculating loss, or the data may simply capture different time periods. Sport England holds data post 2000 on the number of planning application consultations affecting playing fields, but this excludes details on playing fields that have been out of use for five years or more, or which cover an area of less than 0.4 hectares, for the reasons outlined in paragraph 2.7 <sup>12</sup>. Examples of other data sources include:
  - The 'Register of Recreational Land', also held by Sport England and predating 1996<sup>13</sup>.
  - Data held by London boroughs on school and other local authority owned playing fields.<sup>14</sup>

Strategies and complete detailed audit of their local playing field provision in preparation for them.

- Other research produced by the National Playing Fields Association,<sup>15</sup> London Playing Fields Foundation,<sup>16</sup> and the Register of English Football Facilities project<sup>17</sup>.
- Sport England's Active Places database includes information on playing pitches which is being added to as part of on-going work.

#### Availability in London

- 2.9 We felt that there was more mileage to be gained in identifying playing field availability across London. Our research sets out an analysis of availability of playing fields on a borough by borough basis. It identifies (as far as data allows), the location of the sites, who owns them, and whether they have a grass or synthetic pitches.
- 2.10 We also thought that it would be useful to set out availability at the sub-regional level. For this purpose we adopt the sub-regional boundaries used in the sub-regional development frameworks. A sub-regional approach was taken by London Playing Fields Foundation in preparing a strategy for north London boroughs<sup>18</sup>.
- 2.11 We should point out that our research does not at this stage, identify whether the specified site accommodates a single or multiple number of playing pitches. This is an element of the research that could be refined and updated in future years.
- 2.12 There are approximately 1,500 available sites with pitches across London. Most of them (around 1,300) contain grass pitches, with the remainder being made up of synthetic surfaces (61), and a mixture of both (79). Playing fields in outer London far outweigh the number of playing fields in inner London. Approximately 1,200 of the available sites can be found in outer London, and a mere 230 in inner London. Nine hundred and seventy five more playing fields are listed for outer London (1202 minus 227), against a population increase of 1.5 million. See Appendix 3.
- 2.13 The minimum number of available sites in an outer London borough is 30. A similar figure, (36) represents the maximum number of sites in an inner London borough. Two outer London boroughs, Bromley and Hillingdon boast over 100 available sites each. By contrast six inner London boroughs, Camden, Kensington and Chelsea, Hackney, Islington, Tower Hamlets and Westminster, along with the City of London each have less than 10 available sites.

2.14 Appendix 3 to this report sets out a full listing of available sites.

#### Keeping track of availability

- 2.15 It is essential to keep track of what is happening to London's playing fields. We believe that the research completed as part of this inquiry provides the crucial first step. The research provides a single central reference point for available sites in London, and a baseline for further research.
- 2.16 The data will need to be regularly monitored and updated, we would suggest annually. This will help to identify future trends and provide key insight on access issues discussed in the next chapter. We would also suggest that the monitoring data be included in the Mayor's State of the Environment report. On that basis we would argue that responsibility for amending and monitoring the database would best sit with the Data Management and Analysis Group of the Greater London Authority, working closely with London boroughs and other key stakeholders.
- 2.17 We would suggest that London-focused records draw on, and develop on existing data from Sport England's Active Places database. The Active Places database includes information on eleven different facility types, including playing fields, across the country. Over 50,000 facilities are included<sup>19</sup>. For example, additional data could include information on quality of pitches and ancillary facilities available.

#### Recommendation 2

We will work with the Greater London Authority's Data Management and Analysis Group to develop a central database of playing fields and artificial turf pitches available in London. We recommend that the data be monitored, and updated annually by the Data Management and Analysis Group and included in the Mayor's State of the Environment Report.

## Chapter 3 Improving access to London's playing fields

- 3.1 We may not be able to point to any one data source to provide a precise account of how many playing fields have been lost. There are various reasons for this, as explained in the previous chapter (paragraphs 2.6 2.9).
- 3.2 What we do know is that we need to learn from past losses and safeguard against future ones. The National Playing Fields Association (NPFA) website records some 116 sites in Greater London which have come under threat to some form of development since 1996. Two years earlier the figure stood at 114; the NFPA maintained then that this was "...only the tip of an iceberg" <sup>20</sup>. Not all playing fields identified as being under threat become losses, as they may include playing fields with application for new sports facilities, however the NPFA figures provide a useful barometer.
- 3.3 High use is the best defence against the loss of playing fields. Also, high quality playing fields, which are easily accessible, have ancillary facilities and are well maintained will be valued and well used because they can sustain more matches without deteriorating.

#### Improving access to London's playing fields

- 3.4 Access to grass playing fields can be a problem. The Mayor recognises this and includes specific policies in the London Plan which focus on improving open space provision.
  - "...opportunities for creating new public open spaces should be promoted where possible, targeting areas of deficiency and Areas for Regeneration. Where appropriate this should include opening up public access to privately owned open spaces such as sports pitches ..."<sup>21</sup>
- Our research shows that availability of sites with pitches is far less in inner London than in outer London. Availability is particularly low in central London boroughs such as City of London (2) and Westminster (5), and also in boroughs such as Camden (4), Kensington and Chelsea (5), Hackney (8), Islington (8) and Tower Hamlets (9). See Appendix 3.

#### Privately owned playing fields

In central London most playing fields are privately owned. We were given three examples of privately owned playing fields where members of the public either have no access at all, or have limited access. The centrally located Vincent Square in the borough of Westminster is largely restricted to use by school pupils attending Westminster School. Playing fields in Lincoln's Inn Fields, owned by the Royal Courts of Justice is restricted to use by members of the legal profession. The Honourable Artillery Company cricket ground, off City Road in central London allows limited access to the general public

- 3.7 Where privately owned playing fields are opened up for public use, members of the public may still find themselves excluded. Considerable travel to the sites may be involved. Booking, entrance or membership fees may prove unaffordable. Or they may find it particularly difficult to book the site.
- 3.8 We are pleased to see that the Mayor's London Plan, recognises the necessity of opening up access to privately owned spaces, and exploring innovative ways to do so. We welcome the development of the London Parks and Green Spaces Forum as a mechanism for sharing experience and good practice<sup>22</sup>. However, we are concerned that the Forum membership does not include representation from the local sporting community. We believe that the sporting community will provide an invaluable perspective to conserving green spaces and safeguarding their use for physical activity and should be represented on the Forum.
- 3.9 We believe that if access to privately owned spaces is to become a reality then we will need to create the appropriate forum in which to develop dialogue with private owners. It is important that we maximise use of London's existing resources, particularly in light of the forthcoming Olympics. There is scope for the Mayor, London boroughs and private owners to come together to examine how best to extend access to existing playing fields to the wider community. There is likely to be a cost implication for maintaining the forum but we would argue that this could be met from within existing budgets.

#### Recommendation 3

We recommend that the London Parks and Green Spaces Forum include representation from the local sporting community of London.

#### Recommendation 4

We will actively seek the development of a forum to encourage dialogue between the Greater London Authority, Association of London Government, the London Organising Committee of the Olympic Games, the Olympic Delivery Body, Sport England, other key stakeholders, and private owners of playing fields to increase access. Given the regional remit of the GLA, we would recommend that that it take responsibility for maintaining the forum.

#### Management and maintenance issues

3.10 High management and maintenance costs of grass playing fields may also restrict access. Significant amounts of money are needed to make sure that the playing fields and ancillary facilities are fit for purpose and comply with health and safety rules. We were told that the condition of many publicly owned pitches is so poor that the cost of restoring them to their former state is prohibitive. For sports such as cricket where regular maintenance is essential for

- producing a safe, reliable wicket, many pitches are no longer in use and the implication for participation rates is damaging<sup>23</sup>.
- 3.11 There is also a problem of the lack of a skills base for maintaining green spaces and sports pitches since contracting out was introduced. Work with the Institute of Groundsmanship, Institute of Leisure and Amenity Management and Commission for Architecture and the Built Environment could usefully address this issue.
- 3.12 The lack of any, or adequate changing facilities adds to access problems and reduced participation. The Register of English Football Facilities (2003) found that only 38 per cent of playing fields had changing facilities and of those, many are in urgent need of modernisation, particularly in ensuring access for all<sup>24</sup>. Richmond Park is a classic example. The park has three full size grass rugby pitches but there are no facilities for changing or showering on site. It was noted that the pitches are well used on the weekends but little used during the week. The lack of changing and showering facilities was cited as a possible reason why mid-week use was not as extensive as it could be.
- 3.13 Changing trends in use may also impact on access. With increasing work or home life commitments some people are more likely to opt for quick, easy play, whether formal or informal, which does not place too much demand on their time or pocket. This shift in demand trends impacts on use of grass playing fields, and can result in reduced use during the week<sup>25</sup>.
- 3.14 Playing fields which may suffer from dog fouling, vandalism or fly tipping reduce useability and consequently restrict access.

#### Accessing funding

- 3.15 Access to funding is crucial to providing access to playing fields. Without the necessary financial investment fields may fall into disrepair and demand for use will be reduced. So it is important to identify sources for funding and how to access them. During the course of our inquiry we identified seven possible sources for funding at European, national, regional and local levels. Table 1 on page 15 lists the funding sources and contact details.
- 3.16 Also worth mentioning is the New Opportunities Fund Playing Fields and Community Green Spaces Programme. This was a time limited Lottery funding initiative (2001 to 2005) delivered by Sport England on behalf of the Big Lottery Fund. The programme provided over £6million to cover the costs of saving threatened sites, writing pitch strategies, drainage, levelling, pitch configuration and playground renovation in London.

#### Artificial turf pitches

- 3.17 It was very much the view of the stakeholders we met with that the increasing availability of artificial surfaces has helped to address some access issues. We were told that artifical surfaces, also referred to as artifical or sunthetic turf pitches (ATPs or STPs) for short, can complement the use of grass playing fields, particularly in densely populated areas in London where access to grass playing fields is limited<sup>26</sup>.
- 3.18 The origins of ATPs lie in the United States of America. The first installation in the UK was in 1971 at Islington, London<sup>27</sup>. Materials used to create artificial surfaces have progressed from sand based and water based pitches to the new 'third generation' pitch made of a substance closely simulating natural grass.
- 3.19 Stakeholders felt that ATPs should not be regarded as a threat to grass playing fields. Rather ATPs should be regarded as a complementary mechanism for increasing access to open space for sport use, and for preserving existing grass playing fields. There is a valuable role to be played by ATPs in meeting the needs of team sports especially in inner London. We were also told that there is an increasing need to appreciate changes in the market, and to examine ways in which they could be harmonised, for example cross-subsidy<sup>28</sup> as a means of keeping green playing fields serviceable<sup>29</sup>. Please see the case study below.

#### Case study - Bacon's City Technology College London Borough of Southwark

As well as providing accessibility to an alternative green space, ATPs can provide a useful source of developing income to assist in the maintenance of green playing fields.

In the London Borough of Southwark a partnership agreement between the local authority and an independent school – Bacon's City Technology College will enable the regeneration of the Mellish Fields site previously derelict and subject to flytipping, to provide an affordable, accessible and flexible facility to accommodate youth, community, and sports clubs. The site will include green playing fields and ATPs, with the latter subsidising the upkeep and maintenance of the former.

3.20 We appreciate the role that ATPs have to play, but would urge that it is balanced against full consideration and assessment of their environmental impact. ATPs can sustain a higher level of use than grass pitches but can only make a limited contribution to meeting peak demand. Consistent surface makes ATPs ideal for intensive play and coaching, and floodlighting enables them to be used to full capacity. These two factors help justify the capital investment required. However sensitive siting of pitches will be needed.

# Chapter 4 What more could be done to preserve London's playing fields

4.1 From our discussion with stakeholders, we identified three main areas which will help to ensure that London's playing fields are better protected in the future – better use of current legislation, an improved planning framework and innovative approaches to funding.

#### Harmonised legislation

- 4.2 The Government has put in place a range of legislative measures to help stem the loss experienced across the country during the eighties and nineties. Sport England must be consulted on all planning applications affecting playing fields including land which had not been used in the last five years, and any replacement of a grass pitch with a synthetic surface. This statutory requirement has been in place since 1996.
- 4.3 The then Office of the Deputy Prime Minister revised its guidance on open space, sport and recreation in 2002. The revisions to the guidance, known as Planning Policy Guidance Note 17, required all local planning authorities, in London, the boroughs, to undertake robust assessments of the existing and future needs of their communities for open space, sports and recreational facilities as a vital step in preparing their local development plans and policies for protecting open space.
- In 2004 the Department for Education and Skills revised guidance it had first published in 2001 on the protection of school playing fields and land for academies. The main changes are that the sale of a school playing field must be the absolute last resort and that proceeds of the sale should be invested in the improvement of outdoor facilities before introducing new indoor facilities, and that any new facility is sustainable for at least ten years.
- 4.5 In chapter 2, (paragraphs 2.3 2.5) we highlighted the difficulties that can be caused by the different criteria used to define a playing field.
- 4.6 We are also concerned about the restrictions to legislation, for example the fiveyear disuse rule, that can pose a real threat to the preservation of playing fields. The case study on the former Port of London site on the following page demonstrates this point. Although a positive outcome has been achieved, it follows a rather long and drawn out battle for the preservation of a high quality sports ground, in a case that would otherwise seem to be 'clear-cut'.

# Case study – Former Port of London Authority Sports Ground, Ilford London Borough of Redbridge

The former PLA sports ground which covers some 10.85 hectares, enough space for 27 full size pitches, has not been used for sport for some 16 years. The battle for survival of sporting provision began in 1990.

Proposed plans for re-development were thwarted on three previous occasions. Both Sport England and it's predecessor, the Sports Council submitted representations opposing development.

At the time of the public inquiry in 2001, there was a real possibility that the long period of closure, disuse and neglect of the ground may be accepted as sufficient grounds for allowing alternative development, because the owner of the site was unwilling to consider recreational uses and wished to pursue re-development.. That possibility represented an acute danger of sending a clear message that neglect or closure of sports grounds could bring substantial financial rewards through profitable development.

The current position is that planning permission for a primary school and leisure development has been granted on the condition that sport pitches on the remainder of the site are brought back into use.

#### **Key facts**

#### 1990 public inquiry

Planning appeal was dismissed. The Inspector recognised that the PLA sports ground was a major, quality recreational resource, the closure of which would be great loss to sporting and recreational needs of the area.

#### 1994 appeal

The Inspector concluded that the development would run counter to the government's general aim to meet growing leisure demands and promote greater use of and participation in sport and recreation. He further concluded that the scale of the development would harm the environmental quality of the area.

2001 public inquiry Proposals rejected

# Case study – Gaelic Athletic Association Sports Ground, London Borough of Greenwich

The Gaelic Athletic Association Sports Ground is a 13 acre site which has remained disused and closed to the public since 1994s.

To date 14 applications for proposed residential development have been made. The most recent proposal, if accepted, would result in a 261 housing development.

The sports ground, which has enough space for three football pitches is in a very poor state but believed by local residents to be retrievable.

In light of the interest of local sports clubs in bringing the sports ground back into use, the availability of alternative sites for meeting housing need elsewhere in Greenwich and the growing interest in sports in one of the host Boroughs for the 2012 Olympic and Paralympic Games, Greenwich Council is currently consulting on re-designating the Ground as Community Open Space.

#### An improved planning framework

- 4.7 There is a limited amount of land to accommodate London's growing population and the many competing priorities this brings for land use, including housing, waste management, schools, work places and so on. The London Plan and accompanying range of supplementary guidance documents set out the Mayor's proposals for meeting the competing demands.
- 4.8 The Mayor recently published revisions to policies in the London Plan on housing provision and waste management. The revisions also set out the implications for London in terms of additional land requirements<sup>30</sup>. The Mayor's introductory remarks to the revisions reiterate his commitment to protecting London's green spaces and ensuring local people have access to them. The Mayor also confirms that a higher housing provision target will not compromise other policies in the London Plan such as the continued protection of Green Belt and Metropolitan Open Space.
- 4.9 The open space policies in the London Plan largely focus on their visual amenity value and proposals for retaining them<sup>31</sup>. But there is a further policy which advocates the promotion and development of sporting facilities.<sup>32</sup> Some stakeholders we spoke to felt that specific polices addressing the sporting value of playing fields were needed in the London Plan. One case cited to us demonstrated how the absence of specific policies in the London Plan to protect playing fields has potentially led to significant loss. Had the London Plan included a policy weighted against development on playing fields, there would have been a greater onus on the developer to justify its proposal.
- 4.10 We agree that the London Plan has a vital role to play in protecting London's playing fields, and there is a need for the inclusion of specific policies recognising the sporting and recreational value of them.

#### Recommendation 5

We recommend that the Mayor include specific environmental policies in the revised London Plan actively promoting the prevention of the loss of green spaces used as playing fields, and an increase in new ones. These policies should consider the wider issues of social, physical and health benefits to be gained from preserving green spaces as well as the visual amenity benefits.

# Case study – St Joseph's Academy, London Borough of Lewisham

The Mayor was consulted on an application for planning permission for the redevelopment of an existing primary and secondary school to provide a new nursery, primary and secondary school. The development would have resulted in the loss of two **full** size grass football pitches and a cricket pitch, to be replaced by five-a-side grass and artificial pitches.

Although the Mayor initially directed the local authority to refuse planning permission, it was done on the grounds of failure to meet his environmental policies on renewable energy and sustainable building, and not on the basis of the potential loss of green space.

The Mayor lifted his direction to refuse planning permission in July 2005, having received further representations on how the energy and sustainable building policies would be met<sup>33</sup>.

Sport England objected to the application and referred it to government for consideration. The application was not 'called-in' by the Deputy Prime Minster. The local authority granted planning permission.

The London Plan has a vital role to play in protecting London's playing fields, and that there is a need for the inclusion of specific policies recognising the sporting and recreational value of them.

#### Section 106

- 4.11 Section 106 agreements enable a planning authority to encourage development which is complementary to its planning policies, and also provides an excellent means of securing financial investment towards maintaining existing playing fields and creating new ones. Under the section local planning authorities may enter into agreement with a developer for the purpose of restricting or regulating the development or use of land, either temporarily or permanently. In London each individual borough is the local planning authority for its area.
- 4.12 We believe that London Boroughs are missing out on a valuable opportunity to protect existing playing fields and help create new ones by using Section 106 agreements. Several of the stakeholders we met with were concerned that Section 106 agreements were not being used to their full potential<sup>34</sup>.
- 4.13 The extent to which individual agreements are successful appears to be largely dependant on the individual knowledge, experience and expertise of those brokering the agreement. The shortage of experienced personnel and high turnover of staff may mean that opportunities are missed.
- 4.14 We recognise that Section 106 agreements are just one of a number of mechanisms for preserving playing fields. However we would urge boroughs to

ensure that they are fully aware of the benefits, particularly in light of current proposals for change outlined in the report following the Barker review<sup>35</sup>.

Open space strategies

- 4.15 In line with guidance published by the former Office of the Deputy Prime Minister's (see paragraph 4.3), boroughs are required to complete Open Space Strategies. Additional guidance published by the Mayor in March 2004 sets out the requirements for completing an Open Space Strategy in line with the London Plan<sup>36</sup>.
- 4.16 Open Space Strategies are an essential tool in helping to determine local availability of green spaces used for sport. Boroughs are required to complete playing pitch audits as part of strategy development. Without a comprehensive audit boroughs will be hard placed to fully assess local provision and whether local demand matches supply. Sport England's Playing Pitch Strategy sets out a method for completing playing pitch assessments<sup>37</sup>.
- 4.17 The lack of reliable data will continue to hamper the development of appropriate policies and strategies to protect playing fields. However, the projected increases in London's population (eight million by 2016), together with the objective of increasing physical activity, make it unlikely that playing pitches can be regarded as 'surplus' to community needs.
- 4.18 We were disappointed to learn that despite the publication of national and regional guidance, only eight London's boroughs have completed an Open Space Strategy in line with the Mayor's guidance. Two have completed Open Space Strategies in line with national guidance, and a further two have completed strategies in line with other Best Practice Guidance. Seven boroughs are in the process of completing Open Space Strategies. Nine boroughs have alternative strategies in place, while in four boroughs no form of strategy is currently available<sup>38</sup>. See Appendix 4 for the full analysis.
- 4.19 We believe that both the government and the Mayor should place a stronger requirement on local planning authorities (the London boroughs) to complete Open Space Strategies as a matter of priority. Ways in which this can be achieved is open to discussion. In the meantime, we would suggest a) the Planning Policy Guidance Note 17 be more strongly worded, and b) the Mayor include the requirement to develop an open space strategy in the revised London Plan. We would welcome the opportunity to engage in discussions with government, the Mayor and other key stakeholders on possible resolutions.

#### Recommendation 6

We recommend that the Government's Planning Policy Guidance Note 17: Planning for sport, open space and recreation, places a more strongly worded requirement on local planning authorities to complete open space strategies.

#### Recommendation 7

We recommend that the Mayor in incorporating specific policies towards protecting and developing new playing fields, seek also to include a requirement for London boroughs to develop an open space strategy by 2009 and that this requirement be adopted in the revised London Plan.

4.20 Boroughs may be daunted by the prospect of undertaking such extensive analyses by themselves, given the financial and personnel resource implications. We would advocate the sub-regional approach undertaken by the London Playing Fields Foundation and boroughs in the north sub-region which may provide a suitable model for the remaining boroughs in taking their work forward on a strategic basis.

#### Recommendation 8

We recommend that boroughs in London's Central, South, East and West sub-regions consider developing a sub-regional strategy towards identifying and preserving green spaces used as playing fields, and that they refer to the work carried out in developing the North London Sub Regional Playing Field Strategy.

#### Innovative approaches to funding

- 4.21 There is a lack of awareness of how to go about securing funding for managing, maintaining or upgrading playing fields or facilities. We were given examples of three models which are working well. The first model demonstrate the value of a partnership approach and the complementary use of artificial turf pitches (ATPs) the Mellish Fields site (see page 16). Mellish Fields is in the process of development and will be a partnership venture between the London Borough of Southwark and Bacon's City Technology College. Revenue from the ATPs will be used to subsidised the costs of maintaining the grass playing fields.
- 4.22 The second model involves a partnership arrangement with commercial operators. We have two examples. Through a commercial partnership with Powerleagues, Fairlop Oak Playing Field in Hainault, owned by the London Playing Fields Foundation, provides 12 floodlit artificial turf pitches in addition to the two grass pitches. The Peter May Sports Centre in the London Borough of Waltham Forest, is a joint venture between the London Playing Fields Foundation (a charity) and the Health Club (Walthamstow) Limited. Rental

- received from the health club subsidises the costs of maintaining the grass playing fields.
- 4.23 Our third model is from outside London, and was brought to our attention through our discussions with Supporters Direct<sup>39</sup>. The Salford Sports Village project aims to create a Community Sporting Hub accessible to local people. Key partners in the project include Salford City Council, Manchester Football Association and Lower Kersal and Charlestown New Deal for Communities. Funding for the project comes from a range of sources, including the European Regional Development Fund, Neighbourhood Renewal, the Football Foundation and Neighbourhood Renewal.

#### **Concluding comments**

- 4.24 We welcome the comments of Richard Caborn last year. Commenting on statistics published in July 2005<sup>40</sup>, the then Sports Minister said
  - "... we are not complacent. There is always more to do and the Government is continuing to work to further improve the protection afforded to playing fields".
- 4.25 We strongly agree that there is no room for complacency. We acknowledge that the planning system is now in an improved position for protecting playing fields generally. However more work is needed to help address the imbalance in playing field provision between inner and outer London, and to increase access to privately owned playing fields.
- 4.26 We believe that further opportunities exist for Government, the Mayor and other key stakeholders to protect London's green spaces used for sport, increase participation in team and outdoor sports and improve Londoners' health to increase on current achievements.
- 4.27 We would argue that the best defence against the loss of a playing field is intensive use by the local community. If sites are to be protected and created for future generations to enjoy, providers of them must ensure that they are accessible, safe and attractive to local people. Effective use of the planning framework, along with joined-up thinking, partnership working and the exploration of innovative models for financing will be essential.
- 4.28 The forthcoming Olympics and the legacy it will generate, and the impending review of the London Plan provides a timely opportunity to review the situation. We would wish to see full consideration given to our proposed changes and their adoption at the earliest opportunity.

## Appendix 1 The recommendations

#### Recommendation 1

We recommend that the Government revise Town and Country Planning General Development Procedure Order 1995 (as amended), to require Sport England to be consulted on all applications for developments on playing fields measuring 0.2 hectares or more.

#### Recommendation 2

We will work with the Greater London Authority's Data Management and Analysis Group to develop a central database of playing fields and artificial turf pitches available in London. We recommend that the data be monitored, and updated annually by the Data Management and Analysis Group and included in the Mayor's State of the Environment Report.

#### Recommendation 3

We recommend that the London Parks and Green Spaces Forum include representation from the local sporting community of London.

#### Recommendation 4

We will actively seek the development of a forum to encourage dialogue between the Greater London Authority, Association of London Government, Sports England, the London Organising Committee of the Olympic Games, the Olympic Delivery Body, other key stakeholders and private owners of playing fields to increase access. Given the regional remit of the GLA, we would recommend that that it take responsibility for maintaining the forum.

#### Recommendation 5

We recommend that the Mayor include specific environmental policies in the revised London Plan actively promoting the prevention of the loss of green spaces used as playing field, and an increase in new ones. These policies should consider the wider issues of social and physical benefits to be gained from preserving green spaces as well as the visual amenity benefits.

#### Recommendation 6

We recommend that the Government's Planning Policy Guidance Note 17: Planning for sport, open space and recreation, places a more strongly worded requirement on local planning authorities to complete open space strategies.

#### Recommendation 7

We recommend that the Mayor in incorporating specific policies towards protecting and developing new playing fields, seek also to include a requirement for London boroughs to develop an open space strategy by 2009 and that this requirement be adopted in the revised London Plan.

#### **Recommendation 8**

We recommend that boroughs in London's Central, South, East and West subregions consider developing a sub-regional strategy towards identifying and preserving green spaces used as playing fields, and that they refer to the work carried out in developing the North London Sub Regional Playing Field Strategy.
