Where the Resident Ballot Requirement applies to an estate regeneration project, landlords may apply for one of the following five exemptions:

Exemption 1: Demolition of social homes required to facilitate a major infrastructure project/s

Exemption 2: Demolition of social homes required to address concerns about the safety of residents

Exemption 3: Demolition of social homes required to reconfigure provision of supported and/or specialist housing

Exemption 4: Planning permission secured on or prior to 18 July 2018

Exemption 5: GLA funding committed on or prior to 18 July 2018
