M51. Delivering Social Infrastructure

Would Policy S1 provide an effective and justified approach to the development of London's social infrastructure? In particular:

- a) Would Policy S1, in requiring a needs assessment of social infrastructure and encouraging cross borough collaboration provide an effective and justified strategic framework for the preparation of local plans and neighbourhood plans in relation to the development of social infrastructure?
- b) Would it provide a justified definition of social infrastructure?
- c) Would it provide an effective development management framework for boroughs, particularly with regard to Policy S1D, F and G?

Would Policy S2 provide an effective and justified approach to support the provision of health and social care facilities in London? In particular:

- a) Would it adequately provide for preventative health and social care to meet the aims of Policy GG3 'creating a healthy city'?
- b) Would it provide effective and justified guidance on development management matters with appropriate flexibility to reflect local circumstances?
- c) Overall, would it meet the aims of Policy GG3DA, in respect of planning for appropriate health and care infrastructure?

M53. Education and Child Care Facilities

Would Policy S3 provide an effective and justified approach to support the provision of good quality education and childcare facilities in London? In particular:

- a) Would it provide appropriate guidance on development management matters taking account of local circumstances?
