St Patrick's Day Schools Art Competition Terms and Conditions

- The competition is open to London schoolchildren aged between 5 and 11 on 1 September 2017.
- There are two age categories to enter:
- 5-7 years; 8-11 years
- A teacher must enter a child / group of children from their school. Before doing so, teachers must have parent/guardian's permission.
- Entries must be sent in via the official entry form, one form per entry available at www.london.gov.uk/stpatricks. We will reject entries that are not made on the official form. We are not responsible for late, lost or delayed entries. This includes network computer hardware or software failures of any kind that may delay or restrict entry to the competition.
- All entries should respond directly to the challenge to design a banner for the London St Patrick's Day Parade.
- Banners should be in the spirit of St Patrick's Day, a welcoming celebration for all.
- The banner size MUST be landscape A4. We will not accept banners in other formats.
- All banners must be two dimensional. We cannot accept 3-D banners.
- Original artwork can be produced in any material (paper, cloth etc including digital images).
- Entries can be sent in digital form in full-colour. They should be JPEG, GIF or TIF files of a high resolution, and no more than 5MB. This may be a digital photo of a 2-D, a scan of a photo of the work, a scan of 2D work, or a digital drawing/painting.
- Entries can also be sent in original form to St Patricks Day Banner Competition, PP17, FREE POST LON15799, City Hall, The Queens Walk, London, SE1 2BR.
- By completing and submitting the entry form, and checking the 'I Agree' tick box indicates you accept these terms and conditions.
- The competition opens for registration and entries from 30 October 2017. The deadline for entries is midnight on 15 January 2018.
- Teachers can upload as many entries as they want. However, only one image per entry may be submitted.
- The judges' decisions will be final and binding. We will not correspond or communicate on winning entries.
- We will notify winners via their school by 1 March. If we cannot contact any winner, or a prize remains unclaimed 10 days after being notified, it will be forfeited. We will then choose a new winner for that prize. The first names of winners will be posted on the website from 13 March 2017.

- All winners will get a prize of art materials allocated by age group. We may award different prizes for group winners. A minimum of 10 prizes will be available. There will be no alternative to the prizes.
- Winners' work will be collected and photographed. It will then be shown in an exhibition at City Hall between 13 March and 20 March 2017. Original works should be picked up by winners or their parents / teachers.
- We will not be liable for any loss or damage, however caused, to any entries and bear no responsibility for incomplete or delayed entries.
- We reserve the right to cancel the competition at any stage if we deem necessary, or for reasons beyond our reasonable control. We will have no liability to the entrants in respect of any such cancellation.
- Winners grant us. the competition sponsors and all media partners an irrevocable, perpetual licence to reproduce, enlarge, publish or exhibit, mechanically or electronically on any media worldwide (including the internet) their artwork.
- Winning entrants shall not object to any cropping or other minor alteration of the photographs of their artwork when used outside the remit of this competition.
- By entering the competition, the teacher confirms and warrants that the child's or children's artwork that has been submitted:
- is their own original work;
- that all copyright, and any other intellectual property rights in the artwork photograph are vested in the child and they have not assigned, licensed or disposed of or otherwise encumbered any of their rights in the artwork;
- does not infringe the intellectual property rights of any third party in respect of the artwork, and the school will indemnify the GLA against any claims made against the GLA by any third parties in respect of such infringement; and

☐ by entering the competition, the teacher confirms and warrants that they have the permission of those pictured in the artwork (if any) (or, where the artwork pictures any persons under the age of 18, they have obtained the consent of that child's parent or guardian) for the photo to be published and used us as contemplated by these Rules of Entry.

- There is no charge to enter the competition. However, all materials for the production and submission of artwork, in all forms, must be provided by the schools.
- The promoter is the Greater London Authority, City Hall, The Queen's Walk, More London, London SE1 2AA ('the GLA').

• We, the GLA, and our service providers, will use your personal information for the purposes of administering this competition, informing you if you have won and if so, issuing your prize. We will publish the names and ages of winners, and the schools they attend on the website from 1 May 2015. This information will also be included alongside the winning artworks where published, exhibited or used in any press/marketing material. We will safeguard your personal information in accordance with the requirements of the Data Protection Act 1998.
