#### 1. Introduction

- 1.1. This Statement of Common Ground has been prepared between the Old Oak and Park Royal Development Corporation (OPDC) and Historic England. It seeks to help to inform the independent examination of OPDC's Local Plan and will be submitted to the Planning Inspector.
- 1.2. It sets out where issues have been resolved and includes Historic England's agreement in relation to the Planning Inspector's proposed amendments in relation to Inspector's Question 3 in relation to Policy D8.

#### 2. Background

- 2.1. OPDC and Historic England have worked closely together throughout the development of Policy D8.
- 2.2. In response to the Regulation 19(2) consultation, Historic England requested that Policy D8 was amended to strengthen and clarify its implementation. OPDC agreed to make these amendments which were included in the <a href="Proposed Minor Modifications Schedule">Proposed Minor Modifications Schedule</a> (KD4). These are also set out in table 1 below.
- 2.3. Following OPDC's response to Inspector's Question 3 in relation to Policy D8, the Inspector set out some proposed modifications to the policy and asked that these were discussed with Historic England.

#### 3. Areas of agreement

3.1. Historic England agrees with the proposed minor modifications set out in table 1 below.

#### (c) Proposals should:

- (i) reflect in their design a positive response to non-designated heritage assets; and (ii) avoid an unjustified adverse effect on the significance of non-designated heritage assets;
- (d) proposals to demolish a building in a Conservation Area will only be permitted after approval of and commitment to the construction of a replacement building;
- (e) Proposals that affect or have the potential to affect archaeological heritage assets will be supported, where they demonstrate the appropriate level of investigation and recording.
